## MEMORANDUM OF UNDERSTANDING

#### 1. Preliminary

The parties of the agreement are referred to as Sports University of Tirana (SUT) Albania and as Catholic University “Our Lady of Good Counsel” (UKZKM) Tirana.

#### 2. Purpose and aims of MoU

Object of this agreement is the co-operation between the contracting parties in providing mutual coordination and cooperation in common areas of education, research, global academic and cultural exchanges, in accordance with the terms and conditions set forth herein or in the MOU and executed hereunder in the spirit of reciprocity.

This MoU is aiming to:

- contribute to the internationalization of higher education, to enhance the mobility and mutual knowhow ad experiences exchange in the areas of higher education and research between the two HEI-s;
- explore and collaborate in mobility opportunities such as Erasmus +/ICM, Campus Mundi,etc.;

- facilitate and simplify the recognition of study programs and/or periods of study;
- establish and further the strengthen the collaboration between the parties for the quality enhancement and the exchange of best practices;
- build up mutual trust and explore possibilities of collaboration on various joint study programs and/or research projects in the common fields of education and research;
- Strengthen cooperation and interchange between the concerning academic staff and students of the signing HEI-s.

### **3. Cooperation areas**

UST and UKZKM hereby engage themselves to cooperate in the following educational and research areas and domains:

- Physical Education and Health;
- Rehabilitation and sports;
- Applied Exercise science (biology, biochemistry, genetics, functional anatomy, biomechanics, physiology, psychology,);
- Sports medicine;
- Physical and sports activity of people with disabilities;
- Physical Activity related to aging;
- Pharmacology and Doping; and
- other areas of mutual interest

### **4. Implemetation of MoU**

This agreement will be implemented on the basis of specific agreements to be drafted and executed in accordance with the general provisions of the MoU.

Specific agreements will provide the relevant activities, financial aspects if any, time periods and detailed obligations of the parties.

Specific agreements are attached to this MoU and are considered part of it.

### **5. Entry into force, term and modifications**

The memorandum of understanding shall enter into force upon its signature by both parties.

The Memorandum of Understanding has validity duration of 5 (five) years from the date of official signing by both parties.

Any modification to the agreement shall require an amendment in writing between both parties duly signed by the authorized representative of UST and UKZKM.

IN WITNESS WHEREOF, the parties hereto have executed the MOU in duplicate with the signatory party representatives of both parties affixing their signatures and with each party keeping an original copy hereof.
