# **PRINCIPLES OF AGREEMENT**

**Concerning the cooperation between**

**Sports University of Tirana**

**and**

**Faculty of Kinesiology, University of Zagreb**

In order to start, develop and broaden the research and didactic contacts between the **Sports University of Tirana** and the **Faculty of Kinesiology, University of Zagreb**, and both **Institutions** decide hereby to conclude the agreement on the cooperation.

## **Forms of cooperation**

1. The exchange of research and didactic staff aimed at: mutual consultations, lecturing, holding practical classes, as well as conducting research projects in field which would interest both Institutions.
2. Conducting conferences, symposia, and academic seminars with participation of representatives of both Institutions.
3. The exchange of students groups aimed at taking special courses, which would interest both Institutions.
4. The exchange of sports groups aimed at competition in sports, which would interest both Institutions.
5. The exchange of information, including publications dealing with physical education and rehabilitation in their broad sense.

## **Terms of cooperation**

The Institution sending its faculty organizes and covers the expenses of the round trip; The hosting Institution organizes and covers the expenses of the stay of the invited guests: provides them with accommodation within the Institution's facilities, full boarding (or, if preferred, pays them the allowance according to the existing rates of the hosting Institution), offers them cultural program, refunds money for public means of transport;

Each part must have its own health insurance.

1. The undertakings defined by art.3 and 4, paragraph 1, are organized according to the mutually accepted framework plan for each year and according to local availability of the budget.
2. Financial base of student and sports groups exchange is defined in mutually accepted framework plan for each year and according to local availability of the budget.
3. The time of stay will result from yearly framework plan of cooperation.

## **Exchange plan**

The framework plan of the scientific program, staff exchange, students and sports groups exchange and financial support for student and sports groups will be prepared each academic year.

## **Final resolutions**

The contract may be terminated at the request of one of the Institutions.  
The contract was drawn up in English – in 2 equal copies.  
The contract will be implemented once the Heads of both Institutions sign it.
