V E N D O S I:

1. Miratimin e pjesëmarrjes së Universitetit të Sporteve të Tiranës në aplikimin e një projekti nën thirrjen EIT HEI dhe nënshkrimin e letrës së dakortësisë për këtë aplikim.
2. Ky Vendim i përcillet Drejtorisë së Zhvillimit të Programeve dhe Digjitalizimit të Shërbimeve Akademiko-Shkencore për publikim në faqen zyrtare të institucionit.
3. Ngarkohet për zbatimin Departamenti i Projekteve dhe Teknologjisë pranë IKSHS dhe Drejtoria e Marrëdhënieve me Jashtë, Publikun dhe Studentët.
4. Ky Vendim hyn në fuqi menjëherë.

LETTER OF INTENT FOR PROJECT APPLICATION

In order to achieve a minimum agreement between the EIT HEI Project and to develop a competitive proposal for a Collaborative Project in response to the call **EIT HEI Initiative Call for Proposals 2024**:

Goals:

The goals of the consortium for the Project are set as follows:

1. Preparation and submission of the project, and if successful,
2. preparation of a grant agreement and negotiation of a consortium agreement, and
3. execution of the Project.

In consequence, the partner has the responsibility to actively participate in the preparation of the proposal: provide the necessary information, participate in the project definition and meetings, allocate resources, respect the planning and deadlines.

Confidentiality:

- All information regarding the structure, set up and technical content of the proposal is confidential and may not be disclosed to third parties without the approval of the disclosing Party.
- No new partner may be contacted or informed about the technical details of the project without prior approval from the Project Coordinator and after signing this letter of understanding.

Consortium agreement:

- **UCAM** is empowered by the Consortium to act as the Project Coordinator with all the corresponding obligations during the negotiation and the execution phases.
- Should the project be granted, the partners engage themselves to negotiate and to sign a Consortium Agreement, on the basis of the joint project, before the signature of the contract between the Project Coordinator and the EIT Raw Materials.

Exclusivity:

During the term of this Agreement, the Parties may not submit a proposal on their own and may not co-operate with any third party submitting a competing proposal to the mentioned Call EIT HEI Initiative Call for Proposals 2024.

Fees:

The technical assistance for the preparation of the joint proposal will be contracted to ZABALA INNOVATION CONSULTING, S.A (ZABALA).

The fee of ZABALA for the **preparation of the proposal will be covered by UCAM and UNAV.**

Furthermore, in case of success of the proposal, ZABALA will receive a **success fee of 2 %** of the granted EC contribution (as in the signed EC-GA) covered by each of the beneficiaries according to their grant. **To cover the received technical assistance for the preparation and management of the joint proposal, XXXENTITY NAMEXXX will receive 98% of its financing, as 2% of the granted EC contribution (as in the signed EC-GA) will be retained by the Project Coordinator (UCAM) to cover it.**

Payment of the proposal preparation fee to ZABALA is thirty (30) days upon receipt of invoice, following proposal submission.

Payment of the success fee to ZABALA is thirty (30) days after the payment of the prefinancing from the coordinator to partners after the signature of the grant agreement between the Contracting Authority and the Project Coordinator.

This Agreement shall terminate without any further demand and without liability of any Party to the others upon the first to occur of the following events:

- automatically upon rejection of the Project by the EIT Raw Materials;
 - automatically upon cancellation of the Project by the EIT Raw Materials during the negotiation of the Project;
- The Receiving Party's duty to protect Confidential Information as foreseen above shall continue for a period of five years after expiry or termination.

- to be fully eligible in accordance with the criteria set out in the specific call for proposals;
