## AGREEMENT BETWEEN DEPARTMENT LEGAL SCIENCE - SALENTO UNIVERSITY AND FOREIGN UNIVERSITIES

### AGREEMENT BETWEEN

The University of Salento (Italy), whose headquarters are at Piazzetta Tancredi, 7, Lecce, Italy (hereinafter referred as to “**Sending Institution**”), represented pursuant to art. 89 of the Statute of Autonomy of the University (D.R. n. 955/2022) for the signing of this agreement by the Department Director of Legal Science, Prof. Luigi Melica, born in Bologna on 13/04/1965 further to the powers vested in him;

AND

The Sports University of Tirana (hereinafter referred as to “**Host Institution**”), address “Muhamet Gjollësja” street, Tirana-Albania, represented for the signing of this agreement by the Rector Prof.Dr. Agron KASA born in Burrel on 06/10/1958 further to the powers vested in him;

hereinafter referred to collectively as the “Parties”.

With reference to the PhD student **Carlo Mormando** of the PhD course in Regulation, Management and Law of Public Sector Organizations for the academic year 2022-2023 (XXXVIII cycle), who was eligible for the PNRR Doctoral Programme, Mission 4, *component 1 Ministerial Decree no. 351/2022*, in which is mandatory to conduct a period abroad of at least six months for research and training scopes, according to the rules set in the framework of the Italian “National Recovery and Resilience Plan” – NGEU funds.

### GIVEN THAT

The Phd position and his scholarship are governed by the laws and regulations in force in Italy and at the Sending Institution, in particular:

- Decree of the Italian Ministry of University n° 226/2021;
- Decree of the Italian Ministry of University n.351/2022 (Next generation EU – Italian “National Plan for Recovery and Resilience”);
- The Rector’s Decree n.433/2022 which contains the Regulation of the University of Salento governing the Phd Programmes it coordinates;
- The Rector’s Decree 643/2022 which contains the approval of the call for admission to the PhD Course XXXVIII for the academic year 2022-23;
- The Rector’s Decree 969/2022 which contains the approval of the ranking lists and name of Phd Candidates admitted to the Phd Programme in **Regulation, Management and Law of Public Sector Organizations** for the academic year 2022-2023 (XXXVIII cycle).

## COMMITMENTS OF THE PARTIES

The Host Institution confirms the intention to cooperate with the University of Salento – Department of Legal Science within the framework of the research project: “Impianti sportivi, diritti e territorio.” (“Sports facilities, rights and environment”) for the PhD student Carlo Mormando

In particular the Host Institution undertakes to:

- receive the PhD student during a abroad period of 6 months (*min 6 months-max 18 months*) for research and training purposes, according to the rules established in the framework of the "National Recovery and Resilience Plan" - FNGEU funds – M.D. n. 351/2022. Provisional period of stay: from 1 January 2025 to 30 June 2025 (*e.g. from 1 June 2024 to 30 November 2024*), at Department of Education and Health / Faculty of Movement Sciences, “Muhamet Gjollështa” Street, Tirana – Albania.
- ensure the overall facilities and contribution required to develop the PhD student's research and training activities during the abroad period.
- guarantee the availability of qualified and specific scientific facilities appropriate to the PhD student's research and training programme;
- ensure the Supervision of **Prof.Dr. Fatos GJATA** ([fgjata@ust.edu.al](mailto:fgjata@ust.edu.al)) – professor at Department of Education and Health / Faculty of Movement Sciences, “Muhamet Gjollështa” Street, Tirana – Albania, who will support the doctoral student during his stay;
- confirm the Phd student's presence at the host institution during the pre-established period, according to the terms and timing that will be requested - if necessary.

The Sending Institution (University – Department of Legal Science) commits itself to ensure:

- the insurance coverage to the Phd Student while performing his research and training activity abroad at the Host Institution;
- the scholarship coverage and top-up scholarship for a period abroad to the Phd student (as foreseen under Italian laws and regulations in force);
- the supervision of Prof. Luigi Melica, scientific tutor and Ordinary Professor in S.S.D. IUS/21, e-mail [luigi.melica@unisalento.it](mailto:luigi.melica@unisalento.it).

The Parties undertake to:

- 1) periodically report on the activities carried out and the results achieved by the Phd student, in accordance with M.D. 351/2022;
- 2) involve the doctoral candidate in joint meetings for the coordination of the research activities covered by this commitment;
- 3) ensure compliance with Article 17 of EU Regulation No. 852/2020 defining the environmental objectives, including the principle of "Do no significant harm" (DNSH) and EU Commission Communication 2021/C 58/01 on "Technical guidance on the application of the principle of "Do no significant harm" under the Regulation on recovery and resilience
- 4) promote, while respecting intellectual property, the exploitation of research results both within the activity of co-financing enterprises, also with a view to technology transfer, and in the scientific field, through an adequate circulation of the results pursued, in any case according to the "Open science" and "FAIR Data" principles;





5) guarantee that the study and research activity of the PhD student carried out in the Institution is the same agreed with the academic tutor, therefore in accordance with the research project assigned in the frame of Next Generation EU Programme – Ministerial Decree n. 351/2022.

For the whole duration of PhD student research stage, no charges will be claimed to Sports University of Tirana, and no fee will be required to the University and/or PhD student.

### **FINAL PROVISIONS**

Pursuant to the General Data Protection Regulation (“GDPR”) (EU) 2016/679, the Parties agree that any personal data will be processed in full compliance with current applicable legislation and for the purposes set out in the present Agreement.

All products and tools, as well as data and results, will be owned by the authors. However, the University may be employing the above mentioned products, tools, data and results for the communications and spreading activities developed within the framework of the PNRR, Mission 4, component 2. Any issues that are not expressly addressed to in the present agreement may be agreed by the Parties in a separated act.
