Mbështetur në nenin 3, pika 4, gërma "c" dhe nenin 38 të Ligjit nr. 80/2015 'Për Arsimin e Lartë dhe Kërkimin Shkencor në Institucionet e Arsimit të Lartë në Republikën e Shqipërisë", në nenin 20, pika "s" të Statutit të Universitetin të Sporteve të Tiranës si dhe në Vendimin të Rektoratit nr. 97 datë 16/12/2024, Senati Akademik,

VENDOSI:

- 1. Miratimin e nënshkrimit e marrëveshjes së mirëkuptimit ndërmjet Universitetit të Sporteve të Tiranës dhe Akademisë Ndërkombëtare Olimpike.
- 2. Ky Vendim i përcillet Drejtorisë së Zhvillimit të Programeve dhe Digjitalizimit të Shërbimeve Akademiko-Shkencore për publikim në faqen zyrtare të institucionit.
- 3. Ngarkohet për zbatimin dhe ndjekjen e të gjitha proçedurave të nënshkrimit Drejtoria e Marrëdhënieve me Jashtë, Publikun dhe Studentët.
- 4. Ky Vendim hyn në fuqi menjëherë.

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING IS ENTERED INTO BY:

- The International Olympic Academy (hereinafter referred to as "IOA"), with registered office at 52 Dimitriou Vikela Avenue, P.C. 152 33, Chalandri, Attica, with VAT/TAX Number 999498191, represented by Mr. Isidoros KOUVELOS, President, pursuant to the provisions of article 149 of Law 4831/2021 "International Olympic Academy (I.O.A.) Olympic Flame Replacement of article 37 of Law 2725/1999" (Government Gazette 170 A/23.9.2021), and
- The Sports University of Tirana, (hereinafter referred to as "SUT") with registered office at "Muhamed Gjollesha" Street, Tirana, Albania, with NIPT number K51712019Q, represented by Prof.Dr. Agron KASA, Rector.

IOA and SUT shall be known collectively as the "Parties" and singularly as "a Party" or "the Party". The objective of this Memorandum of Understanding is to establish partnership of the parties and a framework within joint educational programs and other areas of potential.

1. Introduction

- 1.1. The parties wish to enter into a co-operative relationship for the general purpose of promoting education in and through Olympism and related research.
- 12 This Memorandum of Understanding ("MoU") sets out below the principles by which the parties can establish a formal arrangement regarding suchactivity.

2. Principles

The parties propose the following:

2.1.1. The SUT will nominate students to participate in the Master's degree Programme: "Olympic studies, Olympic education, organisation and management of Olympic events". It is understood that costs for such arrangements shall be met by SUT or by its participating students.

- 2.1.2. The SUT will nominate students to participate in the International Seminar for Postgraduate Students, organised by the IOA. It is understood that costs for such arrangements shall be met by SUT or by its participating students.
- 2.1.3. The SUT will nominate educators of physical education to participate in the International Session for Educators of Higher Institutes of Physical Education, organised by the IOA. It is understood that costs for such arrangements shall be met by SUT or by its participating educators.
- 2.1.4. To consider opportunities for exchange of academic or administrative staff for sharing of good practices and knowledge.
- 2.1.5. To create and implement educational programmes, conferences, seminars, and events between the SUT and the IOA, which are going to take place in the IOA premises in Ancient Olympia, under financial and other terms, which will be specified in the respective agreements.

3. Subsidiary Agreements

It is envisaged that each activity that the parties wish to pursue in accordance with the purpose of this MoU will be governed by terms and conditions to be separately negotiated and agreed upon by the parties through the signing of one or more subsidiary agreements. The parties could entrust secondary units (e.g. schools, departments etc.) to sign the abovementioned agreement, which is under the umbrella of the MoU.

4. Renewal Amendment and Termination

- 4.1. This MoU shall be effective for four (4) years from signing date. Thereafter, this MoU may be extended for a further period of four (4) years or for any other period of time as deemed appropriate by both parties, subject to their consent and any such extension to be made in writing and signed by their authorized signatories.
- Either party may amend this MoU at any time, provided it is with the prior

written consent of both parties.

43. Either party may terminate this MoU at any time by giving six months'

notice to the other party inwriting.

5. General

5.1. The parties to this MoU shall not be deemed to be in breach of this

understanding or otherwise liable to any other party in any manner

whatsoever for any failure or delay in performing or initiating the activities

proposed in this MoU.

None of the parties shall be permitted to use the others' name, crest, logo or

branding without first having obtained the others' prior written consent to

such use and fully complying with the user guidelines and all parties shall

immediately cease use of such name, crest, logo or branding upon

termination or expiry of this MoU.

53. This MoU records the understanding of the parties and is not intended to be

a legally binding document and shall not be enforceable in any Court of

Law.
